ISO 14001 is one of the more popular and commonly referenced ISO standards, with more than 300,000 organizational certifications; used in more than 170 countries. It therefore made sense for ISO to update the standard at the same time it was updating the most popular industry standard, ISO 9001. Under the new High Level

Securing the Global Supply Chain

ISO 28000 may be one of the lesser known ISO standards but as global trade increases so does the importance of implementing a Supply Chain Management system to ensure its security. Approximately 80% of global trade is transported by sea and while the International Ship and Port facility Security (ISPS) code implements actions to secure the maritime aspect (ships/ports) of the supply chain, ISO 28000 asks organizations to consider the measures they need to put in place to secure the rest. The US itself imports goods and services worth approximately \$2.7 trillion. ISO 9001 states that organizations shall remain responsible for all outsourced processes. ISO 28000 gets organizations to think about the security aspect as well both upstream and downstream, at each stage of the supply chain.

QMII recently conducted ISO 28000 Lead Auditor training for the Trinidad and Tobago (T&T) Coast Guard in Port of Spain. QMII is one of the few training providers in the US to provide this training and was also one of the first to offer the training in the US. The course is taught by instructors well versed in the subject and knowledgeable about the intricacies of supply chain security. The course is based upon the Exemplar Global (EG) TPECS certification scheme and recognized by EG. The training in T&T was received by all personnel and the students presented the instructor, Julius DeSilva, with a token of their appreciation (see sidebar).

QMII has also previously consulted and audited to ISO 28000 for other clients both domestic and international.

- > Develop reliable and pliable systems, particularly effective for organizations where process objectives are constantly changing.
- ➤ Determine and communicate the resources necessary to enable the system.
- > Communicate the roles and responsibilities within the QMS to the organization.
- Lead 1st, 2nd and 3rd party audits, particularly on undocumented systems and audit for process effectiveness against measurable objectives.
- > Relate the capabilities of the organization to the expectations of customers, top management and shareholders.
- > Use the QMS to work proactively and not reactively. Explain to customers how the organization plans to fulfill its promises and show evidence that it has done so in the past.
