ISO 9001:2015 and the Risk Element - Part I

The importance of incorporating risk in the changed business environment.

Part 1 of a set of articles by IJ on Risk and [ISO 9001:2015](#)

It is indeed a flat world we live in with better connectivity in communication and transportation making it easier to do business across the globe. There is an undeniable interdependence, not only for raw materials but also for ideas and businesses would probably not be as profitable, for this fact.

With all these changes in the global economy, the international standards cannot stagnate; they have to keep up with the changing environment and so the changes to ISO 9001, [14001](#) and others.

Many raise the question, *'Is risk based thinking replacing the process approach in the [ISO 9001:2015](#) revision?*

Certain experienced practitioners of the 2008 version are of this opinion. In fact, to an extent where the concept of Preventive Action, which has stood the test of time, might this be a case of the baby being thrown out with the bathwater! I ask my readers to firstly question why even introduce risk when we already have preventive action?

ISO 9001:2015 and the Risk Element - Part II

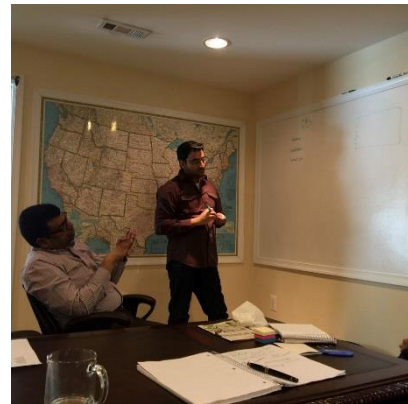
[In part 1 of this series](#), we recognized that Preventive Action (PA) covered the risk element in ISO 9001:2008. PA required analysis of data in clause 8.4 and recognition of trends and potential Non-Conformities (NC) in clause 8.5.3; however it was being done as a separate element. Clause 8.5.3 was the last clause of the standard!

ISO 9001:2015 introduces a systematic approach to the risk assessment at every stage of the organizations operations life cycle starting at the Plan stage. So we see risk mentioned throughout the revised standard and not as a separated component of the Quality Management System (QMS). Clause 8.5.3 in ISO 9001:2008 was reactive to the information from analysis of the data collected as the system was used. In the 2015 revision we have a proactive approach to 'preventing or reducing the undesired effects and promoting continual improvement.' Therefore the PA is inherent and inclusive in a system which is risk based.

Opportunities for improvement (OFI), for example, are part of the Baldrige Criteria. However, ISO 9001:2008 did not consider these. Preventive Action ensured negative effects did not adversely affect the output. The 2015 revision has a positive innovative element to it, with risk being considered throughout the process in it. 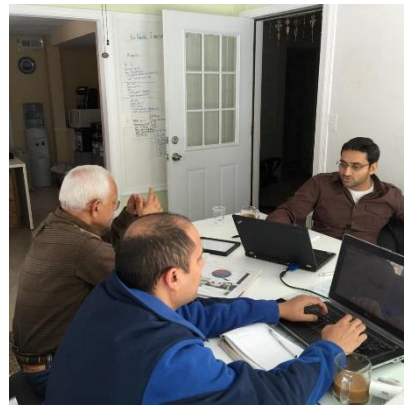

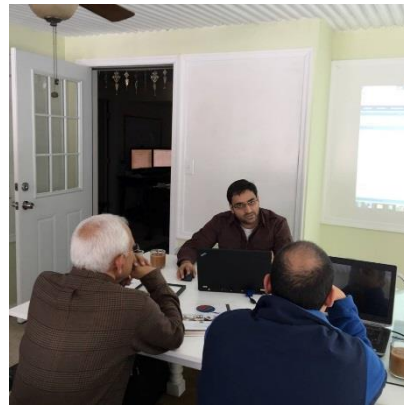
