ISO/DIS 9001 Published

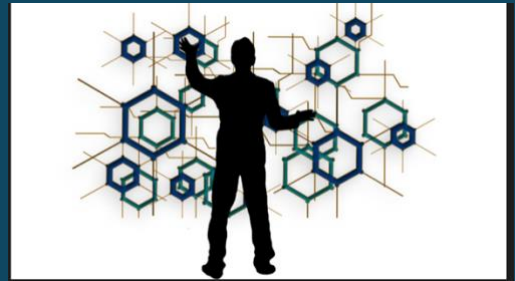
ISO Technical Committee 176 reviews and update the ISO 9001 standard at regular intervals. ISO 9001 has been in review for some time now with the publishing of the Draft International Standard (DIS) delayed.

The ISO/DIS 9001 was finally released on 27th of August 2025 and is currently in the voting process until 19th November 2025. It currently has a tentative publish date of Q3/Q4 2026. QMII has studied the changes. A read of the standard does not reveal any major principled changes. Clause 10.3 has been removed, minor terminology changes have been made and many of the 'changes' are to the notes in the standard. We will keep monitoring the progress on the changes to ISO 9001, ISO 14001 and other harmonized standards due for update and will keep you updated through our newsletters, email blasts and QMII social media. Once the standard is published companies will have 3 years to transition to the new standard.

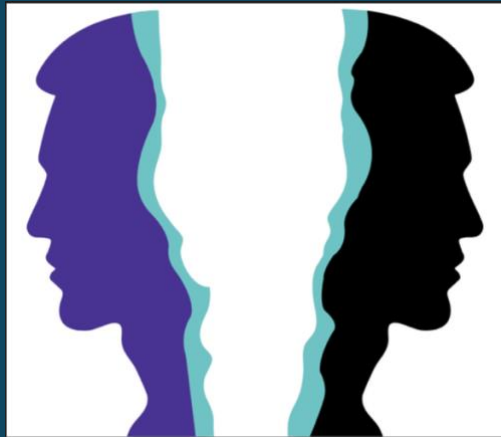
